### **Purpose**

To authorize a three (3) year contract between the City of Shreveport and the Krewe of Centaur relative to the production of the annual Mardi Gras Parade in 2025-2027.

The City of Shreveport has partnered with the Krewe of Centaur for more than 30 years to produce an annual Mardi Gras parade. The current contract between the City of Shreveport and Krewe of Centaur to produce the 2024 Mardi Gras parade expires in December 2024. This resolution would authorize the City to enter and execute a three- year contract with the Krewe of Centaur to produce Mardi Gras parades in 2025 through 2027.

**A RESOLUTION AUTHORIZING A CONTRACT BETWEEN THE CITY OF SHREVEPORT AND THE KREWE OF CENTAUR RELATIVE TO MARDI GRAS PARADES AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

**WHEREAS**, the City desires to support and sponsor cultural and leisure activity programs which serve a public purpose and render a public benefit; and

**WHEREAS**, Krewe of Centaur desires to provide a public benefit through its Mardi Gras Parade and Celebration; and

**WHEREAS**, City desires to enter into this agreement with the Krewe of Centaur, which will enable it to continue to sponsor its programs.

**NOW BE IT RESOLVED** by the City Council of the City of Shreveport in due, legal and regular session convened, that the Mayor is authorized to execute an agreement with the Krewe of Centaur, substantially in accordance with the draft thereof filed for public inspection with the original of this resolution in the Office of the Clerk of Council on July 2, 2024.

**BE IT FURTHER RESOLVED** that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or application, and to this end, the provisions of this resolution are hereby declared severable.
