PURPOSE

To appropriate additional funds received from Louisiana Housing Corporation for the purpose of funding supportive services activities as well as adjust line items relative to public safety funds in support of the Shreveport Financial Empowerment Center.

BACKGROUND INFORMATION

The Louisiana Housing Corporation allocated additional Emergency Solutions Grant (ESG) funds to the City of Shreveport in the amount of \$100,000. This amendment adjusts the Community Development Special Revenue Funds Budget to reflect this additional funding. This amendment will also increase the contractual services line item from existing public safety funding in support of the Shreveport Financial Empowerment Center.

AN ORDINANCE AMENDING THE 2025 COMMUNITY DEVELOPMENT SPECIAL REVENUE FUND BUDGET AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, the City Council finds it necessary to amend the 2025 budget for the Community Development Special Revenue Fund, to adjust appropriations, reflect current revenue estimates and for other purposes.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in legal session convened, that Ordinance Number 125 of 2024 budget for the Community Development Special Revenue Fund, is hereby amended as follows:

In Section 1. (Estimated Receipts):

Fiscal Year 2025 Funds:	
Increase State Emergency Solutions 2025-SESG25	\$100,000.00

In Section 2. (Appropriations):

Fiscal Year 2025 Funds:	
Increase State ESG - 2620 SESG25 Other Charges	\$100,000.00
Decrease PSFEMC Personal Services	\$30,000
Increase PSFEMC Contractual Services	\$30,000

Adjust totals and subtotals accordingly.
