SPONSOR**PURPOSE**

To allow the mayor to execute an agreement with the Parish of Caddo that will allow for a \$100,000 contribution for improvements at the intersection of Flournoy Lucas and Wallace Lake Road.

The City of Shreveport will design, construct and maintain the intersection. Wallace Lake Road is a Caddo Parish road. Therefore, the Parish has agreed to give the City \$100,000 to use toward the project.

**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A
COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE CITY OF
SHREVEPORT AND THE PARISH OF CADDO AND TO OTHERWISE
PROVIDE WITH RESPECT THERETO.**

BY COUNCILMEMBER:

WHEREAS, the City desires to carry out improvements at the intersection of Flornoy Lucas Road (City road) and Wallace Lake Road (Parish road);

WHEREAS, the Parish agrees to assist in the project by contributing funds to the initial design and construction of the improvements;

WHEREAS, the City shall provide the design, construction and maintenance related to the project. The Parish agrees to pay \$100,000.00 to the City as its participation in the project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened, that Tom Arceneaux, Mayor, be and is hereby authorized to execute, on behalf of the City of Shreveport, a cooperative endeavor agreement between the City of Shreveport and the Parish of Caddo for improvements to the intersection at Flornoy Lucas Road and Wallace Lake Road.

BE IT FURTHER RESOLVED that if any provisions or items of this resolution or the application thereof are held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.
