

**RESOLUTION \_\_\_\_\_ of 2025**

**A RESOLUTION AUTHORIZING THE QUERBES PARK FOUNDATION  
TO USE THE NAME “QUERBES PARK” IN ITS FOUNDATION NAME  
AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

**WHEREAS**, the City of Shreveport Department of Public Assembly and Recreation (the "Department") has the responsibility for the management and preservation of public parks in the City of Shreveport, including Querbes Park; and

**WHEREAS**, the Querbes Park Foundation (the "Foundation") is a non-profit organization dedicated to raising funds to improve and promote Querbes Park; and

**WHEREAS**, the Foundation has expressed an interest in using the name "Querbes Park" in its foundation name to recognize the park's significance and to raise awareness of its mission; and

**WHEREAS**, the Department recognizes the potential benefits of the Foundation's efforts, including increased visibility and fundraising opportunities for the Foundation, and the potential for the Foundation to contribute to the ongoing maintenance and enhancement of Querbes Park; and

**WHEREAS**, the Department has reviewed the Foundation's request and deems it to be in the best interest of the public and the park;

**WHEREAS**, the Mayor is authorized to execute any and all documents related to this resolution; and

**NOW, THEREFORE, BE IT RESOLVED** that the City of Shreveport hereby grants permission to the Foundation to use the name "Querbes Park " in its foundation name, subject to the following conditions:

**1. Foundation Name:**

The Foundation shall use the name "Querbes Park Foundation" or a similar name that clearly includes the name of the park.

**2. Use of Name:**

The Foundation's use of the name shall be limited to its foundation name and related promotional materials and shall not be used for any commercial purposes or in a way that could damage the reputation of the park or the City of Shreveport.

### **3. Review and Approval:**

The Foundation shall submit to the Department for review and approval any materials that use the park name, including but not limited to, promotional materials, website content, and fundraising materials.

### **4. Term:**

This permission shall be granted for a period of 10 years, commencing on April 13, 2025, and ending on April 2, 2035. This permission may be renewed by the Department upon the request of the Foundation, and subject to the Department's review and approval.

### **5. Termination:**

The Department may terminate this permission at any time upon written notice to the Foundation, if the Foundation fails to comply with the terms and conditions of this resolution, or if the Department determines that the Foundation's use of the name is no longer in the best interest of the public or the park.

**BE IT FURTHER RESOLVED** that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or application, and to this end, the provisions of this resolution are hereby declared severable.

**BE IT FURTHER RESOLVED** that all resolutions or parts thereof in conflict herewith are hereby repealed.
