**ORDINANCE NUMBER \_\_\_\_\_ OF 2025**

**AN ORDINANCE AMENDING THE 2025 CAPITAL PROJECTS FUND AND TO OTHERWISE PROVIDE WITH RESPECT THERETO**

**BY: COUNCILMEMBERS BOUCHER, BOWMAN, GREEN, TAYLOR, TALIAFERRO, JACKSON**

**WHEREAS**, the City Charter provides for the amendment of any previously adopted budget; and

**WHEREAS**, the City Council finds it necessary to amend the 2025 Capital Projects Fund to adjust appropriations, reflect current revenue estimates and for other purposes.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Shreveport, in legal session convened, that Ordinance No. 120 of 2024, the 2025 budget for Capital Projects Fund, is hereby amended as follows:

In Program A – Building Improvements:

Increase the appropriations for Fire Station 20 Rehabilitation (A24002) Funding source \$1,600,000 from General Fund. (Please note that the City will invoice the Port for \$867,136.87) Adjust totals and subtotals accordingly.

**BE IT FURTHER ORDAINED** that the remainder of Ordinance No. 120 of 2024 shall remain unchanged and in full force and effect.

**BE IT FURTHER ORDAINED** that if any provisions or items of this ordinance or the application thereof are held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
