

ORDINANCE NO. _____ OF 2023

**AN ORDINANCE TO AMEND SECTION 74-52.1 OF THE
CITY OF SHREVEPORT, LOUISIANA, CODE OF
ORDINANCES, RELATIVE TO THE DISPOSAL OF SOLID
WASTE OUT OF STATE, AND TO OTHERWISE PROVIDE
WITH RESPECT THERETO.**

BY COUNCILMEMBER:

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, legal and regular session convened, that Section 74-52.1 of the Code of Ordinances be hereby amended as follows:

Sec. 74-52.1. - Disposal of solid waste.

- (a) Except as provided in subsections (b), (c), and (d) of this section, all persons required to obtain a permit from the city under section 74-53 shall dispose of all solid waste and rubbish collected pursuant to this section, or an equivalent amount as determined by the director of operational services, only at the Woolworth Road Landfill.
- (b) Section 74-52.1(a) shall not apply to any solid waste and rubbish which is being collected for the specific purpose of resource recovery as that term is defined by the State of Louisiana Department of Environmental Quality, Office of Solid and Hazardous Waste, Solid Waste Division.
- (c) Section 74-52.1(a) shall not apply to any building materials disposed of at any construction and demolition facility permitted by the state.
- (d) Section 74-52.1(a) shall not apply to any large tree limbs or tree trunks exceeding four feet in length and four inches in diameter disposed of at any wood waste facility permitted by the state.
- (e) Section 74-52.1(a) shall not apply to any household hazardous waste which is collected separately and disposed of at a hazardous waste facility permitted by the State of Louisiana or any other state.
- (f) Notwithstanding the provisions of section 74-57 and in addition to the application of any other local, state or federal rules, regulations and statutes concerning waste handling and disposal, any person required to obtain a permit from the city under section 74-53 shall be fined \$500.00 per vehicle per day for any violation of this section, each day of violation constituting an individual and separable offense.

BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given effect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all Ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall become effective in accordance with the provisions of [Shreveport City Charter Section 4.23](#).
