Per the above title, this Resolution is to receive authorization from the Shreveport City Council to execute a cooperative endeavor agreement between the City of Shreveport and the State of Louisiana Facility Planning and Control for Bayou Pierre Drainage and Recreation.

Act #465 of 2023 has granted the City of Shreveport State Capital Outlay funding in the amount of \$716,250 which will act as the first funding installment for improvements to the above referenced subdivision.
