A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF SHREVEPORT TO SIGN AN APPROVAL OF THE ASSIGNMENT BY CYPRESS ENERGY PARTNERS, LLC OF THREE OIL AND GAS LEASES TO PALOMA NATURAL GAS, LLC, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the City of Shreveport (the “City”), leased three certain tracts of land, Tract No. 45810 containing approximately 473.0788 acres, and Tract No. 45811 containing approximately 627.3400 acres and Tract No. 45812 containing approximately 293.496 acres to Cypress Energy Partners, LLC on June 12, 2024. WHEREAS, Lease No. 22216 containing Tract No. 45810 was recorded under Instrument No. 2977352. Lease No. 22217 containing Tract No. 45811 was recorded under Instrument No. 2977351. Lease No. 22218 was recorded under Instrument No. 2977350. All three leases were recorded in the Conveyance Records of Caddo Parish, Louisiana; and WHEREAS, CEP is the current owner of the Lease Nos. 22216, 22217 and 22218 (the “Leases”); and WHEREAS, CEP has entered into an agreement with Paloma Natural Gas, LLC (“Paloma”), pursuant to which all of CEP’s right, title and interest in the referenced Leases will be assigned to Paloma; and WHEREAS, in accordance with the terms of the Leases, the City has received a written request from CEP, seeking the City’s consent for CEP to assign their interest in the Leases to Paloma. To the extent required under the Leases, a waiver from the City of any requirements for obtaining such consent, including, without limitation, any right, if any, the City may have to receive any further disclosures of information concerning the details of the assignment of the interest in the Leases; and WHEREAS, the assignment will be made subject to all of the terms and conditions of the Leases; and WHEREAS, Paloma will accept the assignment subject to all obligations under the Leases; and Page 2 of 2 WHEREAS, the City’s consent to assign shall not constitute a waiver of any provision in the Leases; and WHEREAS, the assigned interest may not be further assigned to any third party without written consent from the City, pursuant to the terms of the Leases. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, legal, and regular session convened, that the Mayor is hereby authorized to approve the assignment of the oil and gas leases from CEP to Paloma. WHEREAS, Article VII, Section 14(C) of the Louisiana Constitution provides, "For a public purpose, the state and its political subdivisions or political corporation may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual;" and WHEREAS, Progressive Construction Company is completing a construction project on Interstate 20 that requires a location for short-term vehicle parking and storage of construction materials; and WHEREAS, the City owns the property located at 6970 West 70th Street, Shreveport, Louisiana ("Property") which includes parking lots that are in need of improvements before the property can be used by the City; and WHEREAS, Progressive and the City agree that in exchange for Progressive's use of the property, Progressive will repair and improve the parking lots located thereon after completion of the Interstate 20 project; and WHEREAS, the CEA serves a public purpose by allowing completion of the Interstate 20 project which improves transportation options for Shreveport citizens and provides for improvements to City property making the property location usable for Water and Sewerage facilities. NOW THEREFORE BE IT RESOLVED by the City Council of the City of Shreveport, in due, regular, and legal session convened, that the Mayor is hereby authorized to enter into a Cooperative Endeavor Agreement with Progressive Construction Company, substantially in accordance with the draft thereof filed for public inspection with the original of this resolution in the Office of the Clerk of Council on August 23, 2024. SECTION 2. That a Procés Verbal of the canvass of the returns of the Election shall be made and that a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in her office; that another certified copy thereof shall be forwarded to the Clerk of Court and ex-officio Recorder of Mortgages in and for the Parishes of Caddo and Bossier, who shall record the same in the Mortgage Records of the Parishes of Caddo and Bossier; and that another copy thereof shall be retained in the archives of the Governing Authority. SECTION 3. That the result of the Election shall be promulgated by publication in the manner provided by law. SECTION 4. In accordance with La. R.S. 18:1292(B)(2) the actual cost of holding the election was \$165,868.57. SECTION 5. This Resolution shall take effect immediately upon adoption.
