**PURPOSE**

To modify funds to create a new capital project, Amtrak Platform and Facility, Planning and Construction.

**BACKGROUND INFORMATION**

Act 465 of 2023 appropriated \$1,193,750 in State Capital Outlay funds for a project titled Amtrak Platform and Facility, Planning and Construction. The project will allow for design and construction a boarding platform that will be located on a designated Amtrak train route.

**AN ORDINANCE AMENDING THE CITY OF SHREVEPORT,  
LOUISIANA, 2025 CAPITAL PROJECTS FUND BUDGET,  
APPROPRIATING THE FUNDS AUTHORIZED HEREIN AND  
TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

**WHEREAS**, the City Council provides for the amendment of any previously adopted budget, and

**WHEREAS**, the City Council finds it necessary to amend the 2025 Capital Projects Fund Budget to adjust appropriations and for other purposes.

**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance No. 120 of 2024, the 2025 Capital Projects Fund Budget, be further amended and re-enacted as follows:

**In Program G (Traffic Improvements):**

Establish a project (G25002) entitled “Amtrak Platform and Facility, Planning and Construction” and fund it at \$1,193,750. Funding source is \$1,193,750 in State Capital Outlay funds.

Adjust totals and subtotals accordingly.

**BE IT FURTHER ORDAINED** that the remainder of Ordinance 120 of 2024, as amended, shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that if any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
