In late 2024, the City was paid \$50,000 by Paloma Natural Gas, LLC for work to be performed on a portion of Pines road due to damage caused by one of their operations. The check has been received and deposited. This legislation will reflect the payment in the current Capital Budget.

**AN ORDINANCE AMENDING THE CITY OF SHREVEPORT,
LOUISIANA, 2025 CAPITAL PROJECTS FUND BUDGET,
APPROPRIATING THE FUNDS AUTHORIZED HEREIN AND
TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

WHEREAS, the City Council provides for the amendment of any previously adopted budget, and

WHEREAS, the City Council finds it necessary to amend the 2025 Capital Projects Fund Budget to adjust appropriations and for other purposes.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance No. 120 of 2024, the 2025 Capital Projects Fund Budget, be further amended and re-enacted as follows:

In Program C (Street Improvements):

Increase Project C21001, System Preservation and Improvements by \$50,000. Source of funds is Other Funds.

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance 120 of 2024, as amended, shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
