Per the above title, this Resolution is to receive authorization from the Shreveport City Council to execute a cooperative endeavor agreement between the City of Shreveport and the State of Louisiana Facility Planning and Control for the Amtrak Platform and Facility, Planning and Construction.

BACKGROUND INFORMATION

Act #465 of 2023 has granted the City of Shreveport State Capital Outlay funding in the amount of \$1,193,750 which will act as the first funding installment for the Amtrak platform and facility project.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE CITY OF SHREVEPORT AND THE STATE OF LOUISIANA FACILITY PLANNING AND CONTROL DIVISION OF ADMINISTRATION FOR THE AMTRAK PLATFORM AND FACILITY, PLANNING AND CONSTRUCTION AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

BY COUNCILMEMBER:

WHEREAS, a cooperative endeavor agreement is needed in order to proceed with a project titled Amtrak Platform and Facility, Planning and Construction.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened, that Tom Arceneaux, Mayor, be and is hereby authorized to execute on behalf of the City of Shreveport a cooperative endeavor agreement with the State of Louisiana Facility Planning and Control Division of Administration for the Amtrak Platform and Facility, Planning and Construction.
