COUNCIL DISTRICT**SPONSOR****PURPOSE**

To authorize Mayor to execute Amendment No. 1 to Contract No. 2024-0288 for consulting engineering services for planning and design of capital roadway improvements.

BACKGROUND INFORMATION

Balar Consulting Engineers, Inc. was selected for the RFS #24-700 for consulting engineering services related to planning and design of capital roadway improvements. The City and Balar executed an Agreement Between Owner and Engineer for Professional Services (Contract No. 2024-0288) on August 5, 2024. The contract requires a Task Order be issued for each Specific Project to be performed under the Agreement. Supplemental Agreement No. 1 will extend the services provide in the contract. The cost of services outlined in Supplemental Agreement No. 1 is not to exceed \$240,000.00 and amends the Contract amount from \$250,000.00 to \$490,000.00.

Council approval is required due to the nature of the contract (engineering services) and the cost of those services.
