ORDINANCE NO. 69 OF 2024

AN ORDINANCE AMENDING THE 2024 BUDGET FOR THE GENERAL FUND TO INCREASE APPROPRIATIONS FOR PROPERTY STANDARDS AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

BY: COUNCILMAN

WHEREAS, the City Charter of the City of Shreveport provides for the amendment of any adopted budget; and

WHEREAS, the City Council finds it necessary to amend the 2024 budget for the General Fund to provide additional funding for the demolition of substandard properties.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in due, legal and regular session convened, that Ordinance No. 122 of 2023, the budget for the General Fund be and is hereby further amended as follows:

In Section 2 (Appropriations):

Property Standards:

Increase Other Charges by \$800,000.

General Government:

Decrease Operating Reserves by \$800,000.

TOTAL CHANGE \$0

Totals and subtotals shall be adjusted accordingly.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
