**PURPOSE**

To modify funds in project C25002, Wallace Lake Road At Flournoy Lucas Intersection.

**BACKGROUND INFORMATION**

The City of Shreveport will design, construct and maintain the intersection at Wallace Lake Road and Flournoy Lucas. Wallace Lake Road is a Caddo Parish road. Therefore, the Parish has agreed to give the City \$100,000 to use toward the project. This ordinance is a companion piece to the resolution authorizing the mayor to enter into the cooperative endeavor agreement.

**AN ORDINANCE AMENDING THE CITY OF SHREVEPORT,  
LOUISIANA, 2025 CAPITAL PROJECTS FUND BUDGET,  
APPROPRIATING THE FUNDS AUTHORIZED HEREIN AND  
TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

**WHEREAS**, the City Council provides for the amendment of any previously adopted budget, and

**WHEREAS**, the City Council finds it necessary to amend the 2025 Capital Projects Fund Budget to adjust appropriations and for other purposes.

**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance No. 120 of 2024, the 2025 Capital Projects Fund Budget, be further amended and re-enacted as follows:

**In Program C (Street Improvements):**

Increase Project C25002, Wallace Lake Road At Flournoy Lucas Intersection by \$100,000. Source of funds is Other Funds (Parish of Caddo).

Adjust totals and subtotals accordingly.

**BE IT FURTHER ORDAINED** that the remainder of Ordinance 120 of 2024, as amended, shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that if any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
