**BY COUNCILMEMBER:**

**WHEREAS**, the City of Shreveport will benefit from the funds allocated for expenses related to recreational improvements in Act 776 of 2024;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Shreveport in due, legal and regular session convened, that Tom Arceneaux, Mayor, be and is hereby authorized to execute, on behalf of the City of Shreveport, a cooperative endeavor agreement between the City of Shreveport and the State of Louisiana Department of the Treasury for funding related to “Recreation Improvements” per Act 776 of 2024.
