At the time, he was a freshman at the University of Texas-Arlington, majoring in Radio and TV broadcasting; and WHEREAS, Quinn worked at several stations in several cities, including Dallas Texas, Montgomery Alabama, and Columbia and Myrtle Beach, South Carolina, but something about Shreveport, stuck with him; and WHEREAS, as an on-air personality at KMJJ, he was soon promoted to programmer and took the station all the way to number one in the market; and WHEREAS, Quinn spent two years as a tv reporter for KTAL, but eventually went back to radio to be station programmer and personality for KDKS, a position he's held for more than 25 years. He's been a programmer for KBTT since 2000; and WHEREAS, he has dedicated his career to not only entertaining and informing his listeners, but also connecting with them. If you're at a big event in the city, chances are you'll see Quinn and his stations, KDKS and KBTT, there too.; and WHEREAS, Quinn has been instrumental in bringing a-list celebrities to Shreveport/Bossier. From Frankie Beverly & Maze, to Tank, K-Ci & JoJo, Kat Williams and Cedric the Entertainer. For years, he coordinated the talent for the Juneteenth festival in Shreveport; and WHEREAS, Quinn has won several awards during his career including Radio Programmer of the Year, Radio Station of the Year, a Game Changer Award, and a Shreveport Wall of Fame honor; and WHEREAS, his passion for people drove him to open nightclubs, restaurants, and now a comedy club in the heart of downtown Shreveport; creating opportunities for people to come together as a community has always been important to Quinn; and WHEREAS, he is most proud of his son and daughter who followed in his entertainment footsteps. They are now pursuing their passions in the film and music industries. **AMENDMENT NO. 1 TO ORDINANCE NO 4 OF 2024:** by: Manushka Garcia-Desgage, Assistant City Attorney

**AMEND THE ORDINANCE AS FOLLOWS: Sec. 26-175. – Authority to compromise or settle claims against the city.** (a) Claims where a lawsuit has not been filed against the city.

(1) After investigation in accordance with the policy stated in section 26-172, city attorney or his authorized designee is authorized to compromise or settle any claim against the city without the necessity for the filing of a lawsuit against the city in a matter where such settlement does not exceed \$30,000.00. (2) After investigation in accordance with the policy stated in section 26-172, any claim that is \$30,000.00 or more but less than \$200,000.00 may be settled without the necessity for the filing of a lawsuit against the city only after it has been approved by the risk management committee. (3) After investigation in accordance with the policy stated in section 26-172, any claim that is \$200,000.00 or more may be settled without the necessity for the filing of a lawsuit against the city only after it has been approved by the city council by a motion followed by a vote of the majority of those present and voting, a quorum being present, at a lawful meeting of the council which shall be open to the public. (b) Claims where a lawsuit has been filed against the city. (1) After investigation in accordance with the policy stated in section 26-172, the city attorney is authorized to compromise or settle any claim in a lawsuit against the city in a matter where such settlement does not exceed \$200,000. (2) After investigation in accordance with the policy stated in section 26-172, any claim in a lawsuit that is \$200,000 or more may be settled only after it has been approved by the city council by a motion followed by a vote of the majority of those present and voting, a quorum being present, at a lawful meeting of the council which shall be open to the public. (c) Any such compromise settlements shall be exigible, payable, and paid only out of funds appropriated for that purpose by the city council.

**EXPLANATION OF AMENDMENT:** This amendment returns the threshold to \$30,000 for any claim against the city in which the city does have to file a lawsuit. It also returns the range to between \$30,000 and \$200,000 for any claim against the city in which the city does have to file a lawsuit, if the risk management committee approves. Thus, the language reflects what the ordinance currently articulates.

**AMENDMENT NO. 1 TO ORDINANCE NO 5 OF 2024:** by: Manushka Garcia-Desgage, Assistant City Attorney

**AMEND THE ORDINANCE AS FOLLOWS:** Sec. 90-327. - Hours of operation. Parking meters and parking meter technology shall be operated in parking meter zones every day, except Saturdays, Sundays and holidays, provided, however, that within the meaning of this section, the term "holiday" shall include only days designated as holidays by the city council. Parking meters and parking meter technology shall be operated in parking meter zones between the hours of 8:00 a.m. and 5:00 p.m., except as follows: on Commerce Street and on Milam Street between Commerce and Spring Street parking meters and parking meter technology shall be operated between 8:00 a.m. and 11:00 a.m. only.

**EXPLANATION OF AMENDMENT:** This amendment addressing a typographical error in the second paragraph, correcting "Milani Street" to "Milam Street".

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications and to this end the provisions of this ordinance are hereby declared severable. BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
