**A RESOLUTION AUTHORIZING AN AGREEMENT BETWEEN THE CITY OF SHREVEPORT AND RED RIVER BEND, LLC RELATIVE TO THE USE OF CITY-OWNED PROPERTY AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

WHEREAS, Article VII, Section 14(C) of the Constitution of the State of Louisiana provides that “For a public purpose, the state and its political subdivisions may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual;” and

WHEREAS, the City of Shreveport desires to cooperate with the landowner of the subject property in the implementation of the of an access agreement as hereinafter provided;

WHEREAS, the City of Shreveport has the authority to enter into this Agreement as evidenced by its governmental purpose of rights, powers, privileges and authority that it has or could claim under the Constitution and laws of the United States and of this state;

WHEREAS, the agreement provides for further development and use of this property by RED RIVER BEND, LLC which will create jobs in the oil and gas industry. In addition, it will aid in the safety of the citizens and visitors who drive this route on Highway 511.

WHEREAS, the City of Shreveport has a reasonable expectation of receiving a benefit or value that is at least equivalent to or greater than the consideration described in this Agreement;

WHEREAS, the use of public property is not a gratuitous donation;

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Shreveport, in due, regular and legal session convened, that in consideration of the premises and the mutual covenants herein contained, the parties hereto agree to the terms and condition in the attached cooperative endeavor agreement;

**RESOLUTION NO. 1 OF 2023**

**A RESOLUTION RATIFYING THE AUTHORIZATION AND PROVISION FOR THE WAIVER OF PERMIT, INSPECTION, AND OTHER RELATED FEES FOR ALL TRADES (BUILDING, ELECTRICAL, PLUMBING, MECHANICAL) FOR THE CONSTRUCTION REPAIR OF PROPERTIES DAMAGED DURING RECENT SEVERE WEATHER, AND TORNADOES FOR ALL PROPERTIES WITHIN THE PECAN FARMS SUBDIVISION LOCATED WITHIN THE PARISH OF CADDO, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

WHEREAS, The Honorable John Atkins, President, Caddo Parish Commission issued a state of emergency within the Parish of Caddo on December 14, 2022, in response to the severe weather and tornadoes the parish experienced beginning Tuesday, December 13, 2022.

WHEREAS, the City of Shreveport, Department of Public Works, has received requests to waive the permit, inspection, and other related fees for the construction repair of properties damaged during recent severe weather, and tornadoes.

WHEREAS, a permit is required whenever an owner, authorized agent, or contractor proposes to construct, enlarge, alter, repair, or move, demolish, or change the occupancy of a structure.

WHEREAS, the Division of Permits and Inspections monitors the construction and reconstruction of all buildings in the City of Shreveport and the Parish of Caddo, and applicable local ordinances, assuring compliance with ordinances and policies, and providing administrative support for related activities.

WHEREAS, plans and specifications prepared must bear the name and seal of either an architect, engineer, or contractor registered to do business in Louisiana

WHEREAS, the waiver of permit fees does not exempt the applicant from complying with the Shreveport City Code, including obtaining all permits, approvals, plan reviews, and inspections

required by applicable provisions of the Shreveport City Code.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, regular and legal session convened, that the City of Shreveport is hereby authorized and empowered to waive all permit, inspection and other related fees associated with the construction repair of properties damaged during the December 13th, 2022 severe weather, flooding, and tornadic activity for all properties within the Pecan Farms Subdivision within the Parish of Caddo.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this resolution are hereby declared severable.
