<b><u>PURPOSE</u></b> This ordinance will repeal Ordinance 135 of 2022 that was previously adopted on September 27, 2022. An additional ordinance is presented to the City Council for consideration to take the place of the ordinance being repealed.		
<b><u>BACKGROUND INFORMATION</u></b> Ordinance 135 of 2022 was previously introduced on September 13, 2022 and adopted on September 27, 2022 to change the name of Red Fox Circle in the Mohr Girls' Circle subdivision to God's Country. However, Sec. 78-452(2) of the Shreveport Code of Ordinances requires that the Ordinance not be adopted for 90 days. Therefore, the ordinance adopted on September 27, 2022 needs to be repealed.

**ORDINANCE NO. 135A OF 2022**

**TO REPEAL ORDINANCE 135 OF 2022 AND TO READOPT AN  
ORDINANCE CHANGING THE NAME OF RED FOX CIRCLE  
IN THE MOHR GIRLS' CIRCLE SUBDIVISION, IN SECTION  
25 (T17N-R15W), TO GOD'S COUNTRY, AND TO OTHERWISE  
PROVIDE WITH RESPECT THERETO**

**WHEREAS**, Ordinance 135 of 2022 was previously introduced on September 13, 2022 and adopted on September 27, 2022 to change the name of Red Fox Circle in the Mohr Girls' Circle subdivision to God's Country; and

**WHEREAS**, Sec. 78-452(2) of the Shreveport Code of Ordinances requires that the Ordinance not be adopted for 90 days;

**WHEREAS**, the Ordinance was introduced on September 13, 2022 and should not have been adopted until 90 days; and

**WHEREAS**, in order to properly follow the law as set forth in the Shreveport Code of Ordinances, the prior adopted Ordinance 135 of 2022 should be repealed and this ordinance be adopted; and

**WHEREAS**, on July 15, 2003, the Mohr Girls' Circle subdivision, was filed and recorded in Book 4000, Page 134, of the Conveyance Records of Caddo Parish, Louisiana; and

**WHEREAS**, said subdivision dedicated to the public a cul-de-sac named Red Fox Circle to service two newly re-subdivided lots; and

**WHEREAS**, the City of Shreveport has received a request from Union Mission Baptist Church No. 1 to rename Red Fox Circle to God's Country; and

**WHEREAS**, Union Mission Baptist Church No. 1 is the owner of all the adjacent property, and

**WHEREAS**, in accordance with the requirements of Sections 78-451 & 78-452 of the Code of Ordinances, Red Fox Circle does not memorialize any person and has no local or historical significance; and

**WHEREAS**, in accordance with the requirements of Section 78-451 of the Code of Ordinances, all of the abutting property owners are in agreement to the name change; and

**WHEREAS**, the proposed name change meets the requirements and approval of the City Engineer's Office; and

**BE IT FURTHER ORDAINED**, by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance 135 of 2022 hereby be repealed and this ordinance be adopted.

**BE IT FURTHER ORDAINED**, that to comply with LSA R.S. 18:201, a certified copy of this ordinance shall be provided to the Registrar of Voters for Caddo Parish, Louisiana.

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance shall be filed and recorded in the official records of Caddo Parish, Louisiana.

**BE IT FURTHER ORDAINED**, that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED**, that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.
