**AN ORDINANCE AMENDING THE 2023 BUDGET FOR THE  
GENERAL FUND AND OTHERWISE PROVIDING WITH RESPECT  
THERETO**

WHEREAS, the City Charter provides for the amendment of any previously adopted budget; and

WHEREAS, the City Council finds it necessary to amend the 2023 budget for the General Fund to adjust appropriations, reflect current revenue estimates and for other purposes.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in legal session convened, that Ordinance No. 160 of 2022, the 2023 budget for the General Fund, is hereby amended as follows:

In Section 2 (Appropriations):

**General Government**

Decrease Operating Reserves by \$115,000

**City Council**

Increase Personal Services by \$115,000

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 160 of 2022 shall remain unchanged and in full force and effect.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
