# AN ORDINANCE AMENDING THE 2023 GENERAL FUND BUDGET AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

## BY:

**WHEREAS,** the City Charter of the City of Shreveport provides for the amendment of any adopted budget; and

**WHEREAS,** the City Council finds it necessary to amend the 2023 budget for the General Fund.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Shreveport, in due, legal and regular session convened, that Ordinance No. 160 of 2022, the budget for the General Fund, as amended, be and is hereby further amended as follows:

In Section 1 (Receipts):

Decrease Licenses and Permits by \$370,000 Decrease Transfer from Riverfront Fund by \$750,000. Increase Taxes and Special Assessments by \$11,300,000 Decrease External Service Charges and Fees by \$250,000 Increase Other Revenues by \$750,000

## TOTAL \$10,680,000

In Section 2 (Appropriations):

#### Executive Office

Decrease Personal Services by \$168,500 Increase Materials and Supplies by \$5,000 Increase Contractual Services by \$168,500 Decrease Improvements and Equipment by \$5,000

#### **Property Standards**

Decrease Personal Services by \$100,000 Increase Contractual Services by \$500,000 Increase Other Charges by \$500,000

### <u>SPAR</u>

Decrease Personal Services by \$475,000 Increase Materials and Supplies by \$20,000

## **Finance**

Increase Contractual Services by \$47,000 Increase Improvements and Equipment by \$3,000

## **General Government**

Increase Personal Services by \$1,100,000 Establish Transfer to Streets Special Revenue Fund at \$9,500,000

Police Decrease Personal Services by \$610,000

<u>Fire</u> Decrease Personal Services by \$605,000 Increase Contractual Services by \$300,000

### **Public Works**

Decrease Personal Services by \$500,000 Increase Contractual Services by \$1,000,000

## TOTAL \$10,680,000

**BE IT FURTHER ORDAINED** that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
