SPONSOR**PURPOSE**

To provide the State of Louisiana's Division of Facility Planning and Control a resolution declaring the City of Shreveport's commitment to fund a portion of a \$4,694,000 construction project to construct a road for Resilient Park, also recognized by the State as Greenwood Road Extension, Planning and Construction (50-MR1-21-02).

BACKGROUND INFORMATION

The State of Louisiana has allocated \$1,069,600 in State funding for construction of a road for Resilient Park. The City has \$930,400 of its own funding allocated to a project titled Resilient Park (C22009). The State's title for the project, "Greenwood Road Extension, Planning and Construction" and the City's title, "Resilient Park" are synonymous. The City's capital budget has committed \$930,400 in City funds to be used in conjunction with the State's funding as well as \$2,000,000 from the Parish of Caddo and \$688,634 from AEP. The design is complete and the City is ready for final approval from the State so it can bid the project for construction.

RESOLUTION NUMBER 45 OF 2023

A RESOLUTION DECLARING THAT THE CITY OF SHREVEPORT IS COMMITTED TO USING ITS FUNDING LOCATED IN CAPITAL PROGRAM C (PROJECT C22009) IN ORDER TO COVER ANY CONSTRUCTION AMOUNT OVER THE STATE OF LOUISIANA'S ALLOCATED AMOUNT FOR CONSTRUCTION, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

BY COUNCILMEMBER:

WHEREAS, the State of Louisiana has granted the City of Shreveport \$1,069,000 in project funding for Resilient Park/Greenwood Road Extension (FP&C # 50-MR1-21-02), and

WHEREAS, the City of Shreveport has \$3,619,634 in additional funding to be used in conjunction with the State of Louisiana's funding, and

WHEREAS, the City of Shreveport is committed to covering the difference in construction funding needed to fulfill any bid amount over the State of Louisiana's allocated amount, and

WHEREAS, The City of Shreveport will also use its allocated funding for any additional change orders that may occur.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened, that the City of Shreveport is committed to cover additional funding, over the State of Louisiana's allocated \$1,069,000, for a construction project to build a road for Resilient Park(Greenwood Road Extension), with its existing funding of \$3,619,634 located in its capital budget, Program C, project C22009.

BE IT FURTHER RESOLVED that if any provisions or items of this resolution or the application thereof are held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.
