PURPOSE

To authorize Mayor to execute an Agreement Between Owner and Engineer for Professional Services with Forte & Tablada, Inc. for engineering services related to the University Park Subdivision Roadway & Drainage Improvements (University Park Improvements).

BACKGROUND INFORMATION

Forte & Tablada, Inc. was selected per RFS 24-704 to provide engineering and consulting services for the University Park Subdivision Roadway & Drainage Improvements (University Park Improvements). These services include design of roadway and drainage improvements for University Park Subdivision. Forte & Tablada will assess the project and provide scope of services. Forte & Tablada will also provide survey, geotechnical, and other technical data to evaluate and design the project and develop the most cost-effective methods. The cost of these services is \$250,000.00.

Council approval is required due to the nature of the contract and cost of the services.

WHEREAS, the University Park Subdivision Roadway & Drainage Improvements (University Park Improvements) include design of roadway and drainage improvements for University Park Subdivision, and

WHEREAS, Forte & Tablada, Inc. was selected per RFS 24-704 to provide consulting engineering services for the University Park Improvements Project, and

WHEREAS, the engineering services are to be provided at a cost of \$250,000.00, and

WHEREAS, contracts for services exceeding \$100,000.00 require City Council approval.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Shreveport, in due, regular, and legal session convened, that the Mayor is hereby authorized to execute an Agreement Between Owner and Engineer for Professional Services with Forte & Tablada, Inc. substantially in accordance with the draft thereof filed for public inspection with the original of this resolution in the Office of the Clerk of Council on April 3, 2025.
